

“JACK DANIEL'S FOODWORKS WIN A TRAEGER GRILL” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to NSW and VIC residents aged 18 years or over.
3. Entries into the promotion open on 03/07/24 and close at 11:59pm AEST on 30/07/24 (“Promotional Period”).
4. Employees (and their immediate families) of the Promoter, Participating Store (defined below) and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
5. A participating store is any Foodworks store in NSW and VIC that stocks the Eligible Products (defined below) and displays material relating to the promotion during the Promotional Period (“Participating Store”).
